COMPLAINT FOR DIVORCE

PLAINTIFF, for his/her complaint against the Defendant states and alleges as follows:

1. Plaintiff is a resident of SWEETWATER County, Wyoming, and has lived in the State of Wyoming for more than sixty (60) days immediately prior to the filing of this Complaint. WHEREFORE, the Plaintiff respectfully requests that the Court:

1. Grant the Plaintiff a divorce from the Defendant and dissolve the marriage;

2. Order a just and equitable division of the marital property and debts;

3. Order that:

No party is entitled to spousal support; OR

Reasonable spousal support should be paid by Plaintiff, OR Defendant as the circumstances and facts may require;

4. Order that the wife resume her previous name at the conclusion of this lawsuit if she wishes; and

5. Order such other and further relief as the Court deems just and equitable.
